



# ENROLLMENT - PAYMENT CONDITIONS FOR PRIVATE LESSONS.

## **TUITION PAYMENTS AND DUE DATES:**

•Students pay a monthly tuition full in advance for a total of 4-5 weeks of lessons. •Students are billed on the **17<sup>th</sup>** of each month and payments are due by the **25<sup>th</sup>** of the month for the following month's tuition. •Classes need to be paid full in advance for by the **25<sup>th</sup>** of each month and **completed within that month.** •**Cancelled and/or missed classes are not cumulative or transferable from one month to another.**

**If you are not planning on continuing to study at The Art of Spanish Institute, please inform us as soon as possible so we can open up your seat and cancel your invoice for next month.**

## **CANCELLING-RESCHEDULING CLASSES:**

•Please be advised that we require a minimum of **24 hours-notice** to cancel and/or reschedule your class. **If the student cancels any time after that, he/she will be charged for the entire class.**

•All classes cancelled with a 24 hours-notice can be rescheduled by the end of the month.

•All classes can be scheduled from 9:00 a.m. to 8:00 p.m. Monday-Friday based on the availability of the student and teacher.

•If a student **doesn't SHOW** within the first 15 minutes of his/her class, the teacher will leave the classroom and the student will be charged for the entire class. *If you are running late please contact us so we can inform your teacher.*

**SNOW DAYS:** If 6 inches of snow or more is predicted, classes will be cancelled and rescheduled. We don't want anyone taking a chance and driving in bad weather. We usually make our decision the night before or early morning on the day of the storm.

## **FEES:**

**Registration Fee:** \$75 one time per student.

**Forms of payment:** QuickBooks ACH Bank Transfer (free) & Credit/Debit Card (A Convenience Fee of 3.5% will be charged on all credit/debit card payments).

**Late Fee:** **\$20.00. Due Date for payments is the 25<sup>th</sup> of the month for next month's tuition.**
